SASKATOON – Then-Crown Representative Mike Allen played a role in expediting the purchase of a stake in SaskTel by the Crown corporation, the Public Utilities Board (PUB) alleges in a letter sent to Saskatoon-based lawyer Carl Meyer. The allegation has been made by the PUB in an application for an injunction against Meyer, which has yet to be heard in Court of Queen's Bench. In the application, the PUB alleges that it "now possesses evidence that Mr. Allen ... provided information to Saskatoon-based Ernest Chagnon, an employee of SaskTel, for the purpose of having the PUB agree to authorize the purchase of a 10.5 per cent controlling interest in SaskTel on July 16, 2009." This same information was then used to push for the approval of a joint investment agreement between SaskTel and SaskTel Corp, which also included the expansion of SaskTel's wireless licence to include more of the province. Meyer has argued the fact that Allen was tasked by Premier Brad Wall to help expedite the purchase of a stake in SaskTel speaks to the actions being done on behalf of the Crown. Wall was not available for comment. Wall's office confirmed Allen was a Crown representative between 2007-2013, though only for an employee assistance program. The program was established to provide guidance and support for Crown representatives under the Premier, but was not linked to any particular project or decision made by Wall. "Mr. Allen served as a representative from 2007-2011 and did not have any influence or involvement with the management of SaskTel Corp, the PUB or any f678ea9f9e
